We are writing in support of the Brooklyn Queens Land Trust, a longtime partner of *East New York Farms!*. *East New York Farms!* is a project of United Community Centers whose mission is to organize youth and adults to address food justice in our community through local sustainable agriculture and community-led economic development. We have operated a Youth Internship program since 2000 and currently serve over 35 young people from East New York.

Please accept this letter as an expression of support for Brooklyn Queens Land Trust (BQLT), an organization that Citizens Committee for New York City (CCNYC) has had the pleasure of partnering with for over 10 years. We are excited to know about BQLT's effort to expand and provide more services to support the 36 gardens in its network, many of which are in low income neighborhoods with few community green spaces.

The gardens in its network, however, are not just pretty places to casually glance at while walking by. They are so much more than that: they serve as a reprieve from the concrete and steel of many of our neighborhoods; they are safe spaces for children and families; they facilitate leadership and create educational opportunities; they allow people to grow organic vegetables, fruits, and herbs in neighborhoods where fresh whole foods can be difficult to find; they combat climate change by growing food at the most local level instead of transporting them from thousands of miles away; and they provide a forum for neighborhood residents to meet each other and develop a sense of community.

From West Farms in the Bronx to East Elmhurst in Queens, the groups we support work on projects as varied as community gardening, visual and performing arts, nutrition awareness, composting, beautification, tenant and immigrant organizing, healing circles, physical fitness, public safety, and more. We believe that BQLT's impacts are both significant and much needed, and we hope that it can continue to thrive.
